Types of Services provided by HKEAA

Rechecking

- Applications are processed on a subject basis only.
- Scripts and score sheets of the subject(s) concerned are rechecked for technical errors such as incorrect mark entries and data inconsistencies.
- Candidates are not allowed to apply for rechecking and remarking of the same subject(s).
- Candidates may not apply for remarking of the subject(s) for which they have applied for rechecking, regardless of the results of rechecking.



- In general, applications are processed on a subject basis.
- For Chinese Language and English Language applications may be made on a subject or component basis. Candidates should note that remarking of Chinese Language and English Language on a subject basis does not include the speaking component. Applications for remarking of the video-recorded speaking component have to be made separately. For applications for remarking of a subject component, the scripts and score sheets of the other components of that subject will also be rechecked for technical errors but not remarked.
- For Mathematics, candidates may apply for remarking of both the Compulsory part and Extended part (if applicable) or remarking of either of the two parts.

- After remarking, the final mark is calculated by averaging out all valid marks given by the original marker(s)/oral examiner(s) and the remarker(s) for the subject/paper(s) concerned.
- Remarking is not applicable to Category B subjects (Applied learning), papers under the School-based Assessment Scheme, multiplechoice papers/sections or practical papers.

IMPORTANT

- Day School candidates can ONLY apply via school.
- Candidates may apply for rechecking and/or remarking for up to a total of <u>four subjects</u>.
- An application for one or more components of a subject is counted as one subject.
- Candidates should pay the required fee at the time of application.
- A grade/level change of the component grade(s)/level(s) or the subject grade/level, the rechecking fee paid for the subject concerned will be refunded.

- Candidates will not be given a copy of their marked scripts and/or video recordings in the speaking examinations through applications for rechecking/remarking. (Direct request to HKEAA by candidates only)
- The results of rechecking/remarking for Category A and Category B subjects will be released on Wednesday, 10 August 2016 (tentative)
- HKDSE candidates whose results have been revised after the rechecking/remarking may approach the JUPAS Office within the prescribed period and request reconsideration of their applications for admission to universities.
